GCR places AFB (Ghana) PLC Medium Term Note Programme ratings 'Under Review'

Johannesburg, 18 April 2017 -- Global Credit Ratings has today placed the following final, public long term credit rating of 'BBB(GH)' with a Stable Outlook accorded to the Medium Term Notes ('MTN') Programme of AFB (Ghana) PLC, Under Review.

While the ratings were scheduled to be reviewed by 18 April 2017, GCR expects to publicly release the updated ratings by 19 May 2017. GCR is also in the process of reviewing the Corporate Rating which is expected to be finalised on or before 19 May 2017. The reason for the extension is to align the review date of the Corporate and Structured Finance ratings.

The existing ratings continue to be supported by GCR.
